The **OPERATIONAL COMMAND POST** location shall be at a site selected by the Deputy Commanding General, MG John Natterstad in the Seattle, WA, area.

*The National Chief of Staff, MG Mark, IS RESPONSIBLE FOR THE STAFF REGARDLESS OF THEIR SITE LOCATION. ALL STAFF OFFICERS RESPOND TO AND SHALL BE DIRECTED BY MG MARK, CHIEF OF STAFF. (I.e., The Operational Command Post Staff shall be directed, coordinated and overseen by the Chief of Staff, MG Mark, although physically located in the Seattle, WA, area.)*

**ALL COMMAND AND CONTROL REMAINS WITH THE NATIONAL COMMANDING GENERAL AS BEFORE; HOWEVER, THE DEPUTY COMMANDING GENERAL SHALL PHYSICALLY OVERSEE ALL THE NATIONAL STAFF OFFICERS LOCATED IN THE SEATTLE, WA, AREA.**

**ALL DECISIONS, GUIDANCE, COMMAND AND CONTROL RESIDES IN THE NATIONAL COMMANDING GENERAL. THE DEPUTY COMMANDING GENERAL TAKES ORDERS ONLY FROM THE NATIONAL COMMANDING GENERAL.**

*THE CHIEF OF STAFF, MG MARK, coordinates directly all OPERATIONAL COMMAND POST STAFF OFFICERS and "cc's" MG Natterstad ensuring his ability to provide thorough guidance to the National Staff located in the Seattle, WA, area; all OPERATIONAL COMMAND POST Staff Officers make sure you brief the Deputy Commanding General, MG Natterstad, on all communications between the National Chief of Staff and yourself.*

*Everyone must read and understand the directed specific pages enabling you to fully understand the Command Post Concept of Main and Operational Command Posts.*
